
Colavito co-chairs the Women's Bar Association of the State of New York's Family and Matrimonial Law Committee.





udge A. Gail Prudenti is dean of the Maurice A. Deane School of Law at Hofstra University. She joined the Law School on Sept. 1, 2015, as executive director of the Center for Children, Families and the Law. On May 1, 2017, she was named dean of Hofstra Law, which is widely recognized as a pioneer in fully integrating clinical education into a traditional law school curriculum, while continuing to be at the forefront of legal education with programs in law and technology, health law and family law.

In her various leadership roles, Prudenti has developed innovative programs and instituted many initiatives to enhance the administration of justice and promote the public's trust and confidence in the courts. In April 2020, she was appointed to a newly established COVID-19 Recovery Task Force to oversee the pro bono network of lawyers who would assist New Yorkers suffering from the pandemic. The Task Force is a joint effort of the New York State Bar Association and the state court system.
