She also received the Leadership Award from the National Multiple Sclerosis Society, and in 2006, Touro Law Center named her Outstanding Pro Bono Attorney. Ms. Korth served on the Black and White Ball Committee for NYU Langone Health Cancer Center for Kids and was the honoree in 2015. Along with her spouse, Ms. Korth serves on the Advisory Board of Chaminade High School Parents Club and is an active member of the University of Notre Dame Parents Club.

She is admitted to practice in New York State and before the United States District Courts for the Eastern and Southern Districts of New York, the United States Court of Appeals for the Second Circuit, and the United States Supreme Court.

In addition to the Nassau County Bar Association, she is a member of the New York State Bar Association and is a member of various sections including Cooperative and Condominiums, Commercial and Federal Litigation, and Alternative Dispute Resolution.
